All reforms in the field of legislation are becoming more important during the visits of the President to the regions with well-thought-out initiatives to further improve the support of entrepreneurship, eliminate various bureaucratic hurdles and obstacles, as well as the tasks and instructions.

The Decree of the President of the Republic of Uzbekistan dated May 14, 2019 "On measures to radically improve the system of support and protection of entrepreneurship" and the establishment of receptions for consideration of appeals of entrepreneurs by the Prime Minister of Uzbekistan created an important basis for business development and support.

At the present days, in Jizzakh region, as well as in Zaamin district, the regional, city and district receptions for consideration of appeals of the Prime Minister of Entrepreneurs are fully operational.

The establishment of Public Councils for Entrepreneurship Support at these receptions has increased the importance of preventing red tape and eliminating bureaucratic barriers in the consideration of applications from entrepreneurs.

In order to ensure the Resolution of the Cabinet of Ministers of the Republic of Uzbekistan № 351 of June 5, 2017, the Jizzakh branch of the Republican Center for Basic Entrepreneurship Training held training courses in Zaamin district on February 10-14 this year.

According to the Resolution of the Cabinet of Ministers of the Republic of Uzbekistan №698 of 09.11.2020, certain plans have been developed for the Complex Socio-Economic Development of Zaamin District of Jizzakh Region in 2020-2022. Development industry, agriculture and services in Zaamin district of Jizzakh region, increase in industrial and agricultural production, provision of modern household, trade, transport, medical, tourism and other services to the population, in order to create new jobs, efficient use of existing resources. further improve engineering and communication and social infrastructure, the Cabinet of Ministers decides:

The following should be identified as priorities for the implementation of the Program:

- further socio-economic development of Zaamin district, increase of incomes and living standards of the population, in particular, women, youth and lowincome citizens through employment;
- increase the volume of industrial production through the creation of new production facilities, modernization of existing production facilities;
- creation of favorable conditions for wide involvement of the population in entrepreneurship and further development of family business;
- development of engineering and communication and social including infrastructure, the reconstruction and reconstruction of internal roads, social facilities, increasing the level of access to clean drinking water, natural gas, electricity;
- improving the condition of social facilities, repairing buildings, landscaping, strengthening the material and technical base, radically improving the quality of services provided to the population.

We have all seen and witnessed their contribution to the stability of the economy during the difficult tests of our people last year. Therefore, in spite of the difficult tests in 2020, under the leadership of the head of our state, all urgent measures have been taken to support business, sufficient resources have been allocated and the necessary conditions have been created. It is noteworthy that measures are being taken to eliminate barriers and improve outdated procedures that do not meet modern requirements. This work has laid a solid foundation for the liberalization of the licensing and permitting system and the beginning of a new phase of institutional reform. However, the current period requires a radical improvement of licensing and permitting procedures and the creation of more favorable conditions for business entities through the elimination of bureaucratic barriers. Otherwise, due to excessive bureaucracy and other obstacles, entrepreneurial activity will not develop, which will have a negative impact on economic growth, there will be various abuses, excessive pressure. According to the petition, the abolition of 105 licenses and permits and the simplification of procedures for 115 will open the door for them to start and run a business in certain activities to make it easier for entrepreneurs. The draft law "On licensing, permitting and notification procedures", introduced by the Government, aimed at implementing this initiative, was considered in the first reading at a recent session of the Legislative Chamber of the Oliv Mailis.

CONCLUSION

In conclusion, the main purpose of this document is to regulate the licensing of certain activities, permits and notifications in the field of business. The adoption of the bill will radically improve licensing and permitting procedures, and most importantly, will further improve the business and investment climate in the country.
