Negligence refers to a situation in which the attending physician did not foresee the possibility of harmful consequences of the patient's actions and inaction, but with the necessary care, he foresaw diligence and due consideration for his professional duties and duties, but he was obliged and should have foreseen these consequences. The professionalism of medical personnel is manifested in the fact that in their position, doctors need to know not only a specific field of medicine, but also the relevant field of medicine. CONCLUSION

1. The perforated form of maxillary sinusitis due to technical errors by dentists accounts for 80.7% of patients hospitalized with dentogenic maxillary sinusitis. In 90.8% of cases, the development of inflammatory processes in the sinus is facilitated by premature diagnosis of oral perforation and delayed provision of professional medical care.
2. In 17.6% of the analyzed patients, the presence of foreign objects (crowns, roots of teeth, objects of dressing material) located in the nasal cavity was detected. Technical errors of dentists during endodontic treatment of chronic foci of infection in the teeth of the upper and lower jaws lead to the development of inflammatory and neurogenic complications in 99% of cases.
3. It is known that in today's reality it can not be said that the only judge of the actions of doctors is conscience. Modern development of the Medical Law and the Medical Law. It shows the proper state of the gas regulation mechanism and gives the drug itself an orderly and balanced character.
