To do this, it is required to establish an independent commission and centers, to seriously study the real situation, to start work quickly, the only center that regularly collects all research and information. Because the work and task that you do is ten years of maturity. It is worth noting that public procurement, investment, banking, tax, duty, markets, persons involved in corruption in the construction system will see a good profit. The cases of extreme “weakness”, “weakness” and even sympathy of legislative practice, law enforcement bodies against them interfere with our work, and as a result of this, the cases of acquiring underground and above-ground wealth of the people and the state are increasing.

It can be said that in the countries of the world many such aspects are found when Uzbek politicians, state figures, scientists say they will learn.
