1. In order to determine the results of the use of land resources, an inventory is made of the lands allocated to farmers and farm households.

2. Farmers who use land resources inefficiently should be encouraged to farm farms that use land resources efficiently. In the irrigated areas of these farms, the area is extended to 2 hectares.

- imposing administrative measures on business entities that provide ineffective services;

- improvement of the natural and economic productivity of the fields of production and service delivery in various contracts between the economic subjects, improvement of the penalty mechanisms for determining the wrongdoing in the previous cases;
- we are able to promote the development of both farmers and peasant farms.
