

ISSUES OF ENSURING INFORMATION SECURITY IN INFORMATION FACILITIES

ABSTRACT: - In the process of globalization, that is, in today's information age, the issue of ensuring information security is gaining priority. Today, the issue of ensuring information security is becoming very important and urgent not only in the Internet network or any information system, but also in information facilities. In this article, the issues of ensuring information security in information facilities are considered on the example of safe storage of rare books in information-library institutions, and relevant suggestions and recommendations are developed.

INTRODUCTION

In today's information society, the issue of information security is becoming more and more important. Because if information security is not ensured, as a result, the information or information object, which has a very high value, will lose its value level in a short period of time. This, in turn, requires the issue of the need to pay attention to information security to the first level.

informatization object - information resources, tools and information processing

systems, auxiliary technical means, buildings or objects (buildings, structures, technical means) in which they are installed, or a complex of buildings and objects designed for secret negotiations, used in accordance with given information technologies.

In general, buildings and buildings that need to be guarded or protected from external influences can also be considered as information objects.

On June 7, 2019, the decision of the President of the Republic of Uzbekistan No. PQ-4354 "On further improvement of the provision of information and library services to the residents of the Republic of Uzbekistan" was adopted. According to this decision, today, "the majority of information and library institutions are not provided with modern information and communication technologies, duplicating computers, copying and equipment, fire protection alarm and fire extinguishing, climate control devices, telephone communication, to the population, especially to persons with disabilities and remote, there are no modern equipment for providing services in sparsely populated areas.

Also, based on this decision, "ensuring the security of information-library institutions and the preservation of information-library funds as part of the national and world cultural heritage" is defined as one of the goals, tasks and priorities of the development of the information-library sector. At the same time, as one of the main tasks for solving the priority directions of the development of the information-library sector, ensuring the security of information-library institutions and information-library funds, developing а regulatory-legal and methodological base that regulates the security technology of information-library institutions and information-library funds specified.

In February 2022, according to the information provided by a number of mass media and the official Telegram channel of the General Prosecutor's Office of the Republic of Uzbekistan, a number of rare books kept in the Museum of Rare Manuscripts of the Information Resource Center of the National University of Uzbekistan were lost. In particular, the value of 13-19th centuries stored in the fund of the National University Information Resource Center is 2.6 billion. 56 pieces of manuscripts and 6 pieces of lithographic works of historical and artistic value worth soums were looted and other serious violations of the law were determined, and a criminal case was initiated against the officials and financially responsible persons of the university, as well as the director of the Information Resource Center and others.

These cases observed at the information resource center of the National University of Uzbekistan show how urgent the issue of information security in library institutions is and require new modern approaches to the issue of book storage in institutions.

In order to ensure information security in information-library institutions, it is necessary to focus on the following issues:

provision of information-library institutions with qualified personnel;

introduction of systems designed to control access to the buildings of information-library institutions;

providing the buildings of information and library institutions with fire protection automatic alarm systems;

equipping buildings of information-library institutions, especially rooms where rare manuscripts and books are stored, with means of climate control (air temperature, humidity, etc.);

Providing the buildings of information-library institutions, as well as rooms of the institution where rare books are stored, with video surveillance devices. In this case, it is necessary to ensure that the period of storage of video recordings of the video surveillance system corresponds to the periodicity of studying and checking the condition of rare books and manuscripts of the library. Now we will make a special comment on the above issues that are important to pay attention to in order to ensure information security in

information-library institutions. Supplying information-library institutions with qualified staff is one of the first issues. It is not possible to ensure a high level of information security without providing institutions with qualified personnel.

The introduction of systems designed to control access to the buildings of informationlibrary institutions is a task to ensure information security of information facilities. In this case, every person entering and leaving building of the information-library the institution is monitored. It is necessary to use guards and identification systems to control persons entering and exiting the building of the information-library institution. It is also desirable to ensure the identification of those entering the building through the facial recognition system. Through this, it is possible to track those who entered the building on the appropriate date using the system archive, and clarify the identity of those who visited the building.

Providing the buildings of information-library institutions with fire warning alarm and automatic fire protection systems allows timely warning of the relevant employees in the event of a fire in the building and activation of automatic fire extinguishing means.

Through this, it is possible to monitor the complete video recording of the preservation of rare books and manuscripts during the period between the periods of checking the preservation status of rare books and manuscripts of the library.

Conclusion. In the article, the issues of ensuring information security in information facilities were considered on the example of safe storage of rare books in informationlibrary institutions. Also, based on practice, a number of proposals were made to ensure information security in information-library institutions and ensure safe storage of rare books. When studying some of the articles written by authors in foreign countries on ensuring information security in libraries, it was observed that these articles did not fully address the issues of information security and did not give suggestions on the preservation of rare books.

The conclusion from this article is that the practical application of the suggestions on ensuring information security in information security in information-library institutions allows to achieve positive results, especially in the safe keeping of rare books.
