non-state education on the basis of international treaties of the Republic of Uzbekistan and in accordance with the agreements of the state inspection.

Activities in the field of non-state educational services are licensed by the state inspectorate for quality control of Education under the Cabinet of Ministers of the Republic of Uzbekistan.

- In accordance with the resolution of the Oliy Majlis of the Republic of Uzbekistan dated May 12, 2001 No. 222-II “on the list of types of licensed activities”, activities in the field of providing non-state educational services are included in the types of activities for which a license is required.

- Currently, the licensing of activities in the field of non-state educational services is carried out on the basis of the regulation “on the procedure for licensing activities in the field of non-State Educational Services” approved by the resolution of the Cabinet of Ministers of the Republic of Uzbekistan dated March 27, 2018 No. 241.

- The applicant for a license for a license by type of education in the field of non-state educational services sends the following documents to the state inspection for quality control of education through the Centers of public services or the Unified interactive State Services port

*application for the issuance of a license (it contains the name and organizational and legal form of a legal entity, location, postal address, address of the place of implementation of educational activities, name of a banking institution and bank account number, type of activity being licensed, list of areas of educational activity. In the application for the issuance of a license, the consent and electronic address of the

license applicant for compliance with the requirements and conditions of the license are indicated);

- * conclusions of fire and sanitary and epidemiological surveillance bodies on compliance of existing buildings and rooms with fire safety requirements and sanitary and hygienic norms;

information about pedagogical personnel (a certificate is required in accordance with the decision of the Cabinet of Ministers on teaching foreign languages No. 352 of December 31, 2013);

- * electronic copies of curriculum and programs;

- * a copy of the document confirming the payment of the fee by the license applicant for the consideration of the application. The following are the license requirements and conditions for the implementation of the activities of legal entities providing non-state educational services:

- * Mandatory compliance with the legislation and legislative acts of the Republic of Uzbekistan in the field of Education;

- Organization of the educational process in accordance with state educational standards (state requirements), educational plans and educational programs;

- the presence of premises (rooms) in accordance with the established requirements, intended for the performance of licensed activities in the license applicant, belonging to him by property or other material right;

- modern information and communication of audiences, classrooms;

- equipment with equipment, technical means of training and equipment;

- provide educational buildings with necessary textbooks, educational and methodical literature and other library and information resources and tools for the implementation of the established level of educational programs;
- implementation of educational programs in accordance with the state educational standards of general secondary, vocational and higher education, as well as in accordance with the state requirements for preschool education, extracurricular education, professional development of personnel and their retraining;
- admission of capable and gifted children of families in need of social protection to free education on a competitive basis in the amount of not less than 10% of the total number of pupils in the institution;
- issuing a document on education to graduates in the prescribed manner In the process of its development, Advanced International experiments were studied in depth. In particular, the delegation of the state inspection for quality control of Education organized a business trip to the Republic of Korea. During the visit, the law and legislation of South Korea in the field of non-state educational services were considered. Meetings and seminars were organized in a number of fanatical organizations, the draft decision was discussed, exemplary factors of the skills studied were taken into account.

For example, in South Korean preschool institutions, the main attention is paid to the educational and educational process. That is, the education received during this period will become a ripe-meticulous foundation for the future, a child

The documents of the license applicants became subject to consideration within 10

days. It turns out that before this process was 30 days.

In turn, the number of documents required to obtain a license was simplified and reduced from 9 to 5. It was enshrined that all legal entities have the right to obtain a license to conduct activities in the field of non-state educational services, regardless of their organizational and legal forms.

Together with the ministries of preschool education, public education and secondary special, vocational education centers, expert groups of qualified specialists were formed in the region, District (City) Section. It is natural for these to increase the role of non-state schools in the general secondary education system in common.

This can also be clearly understood by the fact that in such developed countries as the USA, Great Britain, Japan, Germany, South Korea, the quality of education in non-state schools is at a very high level. After all, this is a common taste.
